- **Tailored Plans are for NC Medicaid beneficiaries who need enhanced services for a:**

- Mental health disorder
- Substance use disorder
- Intellectual/developmental disability (I/DD)
- Traumatic brain injury (TBI)

- **Tailored Plans include coverage for:**

- Physical health services
- Pharmacy services
- Care coordination and care management
- Behavioral health services
- Added services, such as wellness programs



- **Tailored Plans launch **DECEMBER 1, 2022**. Here's the plan:**

Step 1: NC Medicaid determines who qualifies for a Tailored Plan.

Step 2: Beneficiaries who qualify are enrolled in the Tailored Plan that serves their county. This is the county that manages their Medicaid case.

Step 3: Beneficiaries can choose their primary care provider (PCP) and Tailored Care Management provider with their Tailored Plan. If they do not choose, one will be chosen for them.

Step 4: Beneficiaries will begin receiving services through their Tailored Plan on December 1, 2022.

- **Who are the tailored plans?**

There are six Tailored Plans, but only one Tailored Plan serves each county.

- **Tailored Plans son para beneficiarios de NC Medicaid que necesitan servicios mejorados para:**

- Trastorno de salud mental
- Trastorno por consumo de sustancias
- Discapacidad intelectual/del desarrollo (I/DD)
- Lesión cerebral traumática (LCT)

- **Tailored Plans incluyen cobertura para:**

- Servicios de salud física
- Servicios de farmacia
- Coordinación y gestión de la atención
- Servicios de salud del comportamiento
- Servicios adicionales, como programas de bienestar



- **Tailored Plans se lanzan el 1 DE DICIEMBRE DE 2022. Este es el plan:**

Paso 1: NC Medicaid determina quién califica para un Tailored Plan.

Paso 2: Los beneficiarios que califican se inscriben en el Tailored Plan que sirve a su condado. Este es el condado el cual administra su caso de Medicaid.

Paso 3: Los beneficiarios pueden elegir su proveedor de atención primaria (PCP) y proveedor de administración de atención personalizada con su Tailored Plan. Si no eligen uno, se elegirá uno por ellos.

Paso 4: Los beneficiarios comenzarán a recibir servicios a través de su Tailored Plan el 1 de diciembre de 2022.

- **¿Quiénes son los Tailored Plans?**

Hay seis planes personalizados, pero solo un Tailored Plan sirve a cada condado.
